<b>A. What Information Do We Collect?</b>	<b>1.1</b>	When you visit our website, you can browse the website without disclosing any personal information about yourself.
	<b>1.2</b>	We use Google Analytics to collect standard internet log information and details of visitor behaviour patterns.
	<b>1.3</b>	We do this to find out things such as the number of visitors to the

various parts of the site. This information is only processed in a way which does not identify anyone. We do not make any attempt to find out the identities of those visiting our website.

- 1.4** Google Analytics generates statistical and other information about website use by means of cookies, which are stored on users' computers. The information generated relating to our website is used to create reports about the use of the website. Google will store this information. ## **B. Cookies**

- 1.1** A cookie is a small file which asks permission to be placed on your computer's hard drive. Once you agree, the file is added, and the cookie helps analyse web traffic or lets you know when you visit a particular site.
